



## DJ Stevie B Mobile Disco Terms & Conditions

The following terms and conditions have been rewritten 18/07/21 and all bookings are now subject to below.

Please note I as a business have had no support from the government since February 2020 as such our industry has suffered immensely, and we simply cannot afford to lose out on revenue from our bookings, this is why there has been some significant changes to the terms and conditions conditions listed below.

All bookings are subject to the collection of the bookers (the person booking) personal details, such as home address including postcode, mobile number and full name.

This information will be held until booking date has elapsed and then deleted.

NOTE: if requested, this information may be shared with the venue or police.

You the booker, are responsible for your guests, safety of myself and any damage to my equipment due to consequences of your guests. As such, therefore any damage caused by any guest in your party including the booker shall result in replacement of goods 'new for old' to as near the specification as the damaged goods with immediate effect.

**All Bookings** are subject to a Cancellation Fee which is based on time until the agreed booking date. This fee will be Invoiced & Details of these fees are as follows:

2-4 weeks before booking	- Subject to 50% of agreed booking fee.
14 to 8 days before booking	- Subject to 75% of agreed booking fee.
7 to 3 days before booking	- Subject to 80% of agreed booking fee.
3 to 1 days before booking	- Subject to 90% of agreed booking fee.
Same Day of booking	- Subject to 100% of agreed booking fee.

Cancellation on arrival for any reason even of out with the control of the booker – is Subject to 100% of agreed booking fee.

Covid-19 the only time I will grant a no cancellation fee is in the event that the venue cancels the event due to government instructions only!

Should the event be cancelled due to guests or main event persons isolating, I must insist on the above cancellation fees.

**Premium Rate events** are Subject to a 100% of agreed booking fee if cancelled at any time.

PLEASE BE AWARE!!!

Premium rate events are as follows: Corporate & Similar, **Xmas** Parties & Hogmanay, any event during Last week of November to second week in February.

I (Steven Brown) will make every possible attempt to fulfil arranged bookings. However, in the event of exceptional circumstances, I shall attempt to arrange another Known and personally approved DJ. However, I will not be liable for my failure to cover any such booking(s), this also includes any loss of earnings by venue / other.

Covid-19 - In the event of I being asked to Isolate (note I am fully vaccinated), I must Comply and can Only Apologise as this is out-with my control and I at this point will not charge any fee.

**Please assist in my safety, and events that follow yours by ensuring that your guests do not approach the booth unless requested to do so. A contact number is provided for your guests to make requests on the day.**

**Masks must also be worn when approaching the booth.**
